Requirement	:	The requirement is for the supply of power and off-take of electricity by SHAPE via the Off-take Point which is connected to the medium voltage network of the Network Operator IEH.

Period of performance	:	Three years (2022-2024)
Bidding procedure	:	Lowest technically compliant bid. This requirement will be competed through the ACO electronic bidding portal at URL: aco.procureware.com .
Funding	:	SHAPE Military Budget (estimated yearly amount: 3.1 MEURO) Reimbursable budgets (estimated yearly amount: 1 MEURO) Estimated total cumulative value of contract: 12.3 MEURO

Classification of IFIB	:	NATO UNCLASSIFIED
Eligibility	:	Firms (1) that originate and are chartered/incorporated within one of the 30 NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within one of the 30 NATO-member nations, being in possession of a legal licence for the supply of electricity power within the Walloon Region of Belgium at the time of bidding and throughout the whole duration of the contract.
