 Requirement : The requirement is for the provision of Duty Free goods for retail sale in the SHAPE Rationed Items Store (accessories, cosmetics, perfume, skincare, Alcohol, wine, aperitifs, cigars/cigarillos, cigarettes and tobacco) in Belgium.
 Type of contract : Fixed Price, Indefinite Delivery, Requirements type contract
 Period of performance : Five (5) years
 Bidding procedure : Lowest technically compliant bid. This requirement will be competed through the ACO electronic bidding portal at URL: aco.procureware.com
 Funding : SHAPE Community Services Funds (SCSF) – NAF (Non Appropriated Funds)
 Estimated annual value of contract: 2 MEURO
 Estimated total cumulative value of contract: 10 MEURO
 Issue Date : August 2020, planned
 Closing Date : October 2020, planned
 Classification of IFIB : NATO UNCLASSIFIED
 Eligibility : Firms (1) that originate and are chartered/incorporated within one of the 30 NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within one of the 30 NATO-member nations, (3) that have performed at least three (3) contracts within the last five (5) years substantially similar in scope and magnitude to the requirement described in the solicitation.
