1. In accordance with the stipulations of the Bi-SC procurement directive 60-70, Annex B, the following information is provided on an Invitation for International Bidding (IFIB) that this Headquarters has the intention to release.

 Title of IFIB : Procurement and installation of worn-out fireproof doors in the SHAPE Command Center (SCC).  
 Requirement : The requirement is for the procurement and replacement / installation of about eighty (80) worn-out fire doors located in the SHAPE Command Center (SCC) in order to meet the governing Host Nation Safety Regulations. It is recommended that prospective bidders to be registered as Qualified Fire Doors Installers through a third party accreditation organization/company or enumerated into an industry-led registry. (i.e. Belgium INSTITUT DE SECURITE INCENDIE-ISIB)  
 Type of contract : Firm fixed-price  
 Period of performance : One-time  
 Bidding procedure : Lowest technically compliant bid  
 Funding : NSIP budget  
 Estimated total value of contract: 500 KEURO  
 Issue Date : May 2020, planned  
 Closing Date : June/July 2020, planned  
 Classification of IFIB : NATO UNCLASSIFIED  
 Eligibility : Firms (1) that originate and are chartered/incorporated within one of the 29 NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within one of the 29 NATO-member nations, (3) that have performed at least three contracts within the last five years substantially similar in scope and magnitude to the requirement described in the solicitation.  
 Partial bidding : It is NOT authorized.
