Notification Of Intent to Invite Bids

**Enterprise License Agreement for
McAfee Software**

IFB-CO-115286-McAfee

Estimated Value: EUR 2,500,000.00 over 3 years

The NCI Agency is planning to issue an Invitation for Bids (IFB) for an Enterprise License Agreement (ELA) for McAfee software licenses and support services for 3 years.

This ELA will support McAfee requirements throughout NATO – at headquarters, commands, agencies and other NATO organisations. The IFB will state an initial volume of software license requirements with the option to expand if NATO's requirements increase.

The NCI Agency expects to issue the formal Invitation for Bid (IFB) October **2020** with an anticipated contract award in **December 2020**.

Please note this IFB will likely include a bid closing date of approximately 21 days.

1. In accordance with Reference A, the NCI Agency, as the Host Nation, hereby gives notice of its intent to issue an Invitation for Bid (IFB) for McAfee Software Licenses and Support.
2. A summary of the requirements of the Invitation for Bid is set forth in Annex A of this letter. The NCI Agency is refining the requirements and will include more details in the Invitation for Bid.
3. The reference for the Invitation for Bid is **IFB-CO-115286-McAfee**, and all correspondence concerning this IFB should reference this number.
4. For planning purposes, the period of performance of the ELA is expected to be three years.
5. The NCI Agency will award one contract for the entire scope of work. No partial bidding will be accepted.
6. The NCI Agency will use the International Competitive Bidding (ICB) Procedure, lowest price technically compliant evaluation. The successful bid, pursuant to the IFB following this NOI, will be that bid which is the lowest price and technically compliant in accordance with the evaluation criteria prescribed in the IFB.
7. National Responsible Authorities are kindly requested to provide Declarations of Eligibility to the NCI Agency, **not later than 14 days from the date of this letter**, of qualified and certified companies that may be interested in receiving an Invitation for Bid for this project. The Declarations of Eligibility (DoE) should include the following information for each of the nominated companies:
 - **Company Name and Address**
 - **Point of Contact, Telephone number and E-mail address.**

This information is critical to enable prompt and accurate communication with prospective bidders. The DoE should be sent to the following point of contact:

8. Please note that requests for participation in this competition received directly from individual companies cannot be considered.
9. The NCI Agency plans to issue the IFB in October 2020 with a bid closing date approximately 21 days after the IFB. Contract Award is planned for December 2020.
10. Bidders will be required to declare a bid validity of six (6) months from closing date for receipt of bids. If the selection and award procedure exceed the bid closing date by more than six (6) months, the NCI Agency may be request firms voluntarily extend the validity of their bids accordingly. Bidders may decline to do so, withdraw their bid and excuse themselves from the bidding process without penalty.
11. The National Authorities are advised that the IFB package will be NATO UNCLASSIFIED.
12. The successful bidder may be required to handle and store classified information up to the level of "NATO RESTRICTED". In addition, execution of the proposed contract may require, in accordance with NATO Security Policy C-M(2002)49, personnel of the successful bidder to be required to hold individual security clearances of "NATO SECRET". Only firms maintaining such cleared facilities and the appropriate personnel clearances will be able to perform the resulting contract.

ANNEX A – Summary of Requirements

IFB-CO-115286-McAfee

McAfee Software Licenses and Support

1. Background

- 1.1. NATO’s requirements for McAfee software licenses cover different geographic regions, different customers and users within NATO, and a wide variety of technical projects.
- 1.2. The NCI Agency is seeking to consolidate all of NATO’s McAfee requirements by establishing a contract with a McAfee re-seller who can offer increased flexibility and cost-savings in a multi-year Enterprise License Agreement (ELA). This ELA would cover software assurance of the current installed base and the purchase of new licences, rather than buying licenses on a per contract basis.
- 1.3. Additionally, the ELA will allow NATO to increase the scope as its requirements increase.

2. Schedule

- 2.1. It is expected that the ELA will be awarded mid-December 2020 so that it will be effective by 1 January 2021.
- 2.2. The NCI Agency plans to award an ELA for a three-year period; the IFB will provide further details regarding the term.

3. Scope

- 3.1. It is intended that this ELA will be the default contract vehicle for all of NATO’s McAfee requirements in the future.
- 3.2. The ELA will include both; a) an initial commitment for licenses that are active upon contract award and, b) a price list for future licenses to be acquired as necessary.

3.2.1. Initial Commitment

To provide prospective bidders a general expectation as to the scope of the ELA’s initial commitment, the following table provides a high-level estimate of the volume and types of licenses that will need to be covered by new McAfee products upon contract award.
